Out-of-state special interest groups are moving state-by-state to restrict the Second Amendment rights of Americans to bear arms. These groups are dropping millions of dollars into the campaigns of New Mexico's politicians to buy influence and silence the voice of ordinary New Mexicans. Senate Bill 8, legislation written and pushed by these out-of-state groups, was passed by the Legislature and signed into law by Gov. Michelle Lujan Grisham this year. This misguided bill will mandate background checks for private gun sales in New Mexico.

Twenty-nine county sheriffs have objected to SB 8, and twenty-five counties have declared they will not enforce it.

Several attempts have been made to petition the New Mexico Secretary of State Maggie Toulouse Oliver to allow a public referendum on SB 8. A public referendum would let New Mexico's citizens directly vote on this far-reaching legislation that will restrict their constitutional rights.

The Secretary of State has rejected those attempts and is trying to suppress your ability to vote this matter!

While there will likely be a court challenge to compel her to place the question on the ballot, Go Rogue New Mexico wants the Governor and the Secretary of State to know that New Mexicans will not be bullied into silence.

Attached is a petition that will be submitted to the Governor and Secretary of State expressing New Mexico's opinion on this matter. **THIS IS NOT AN OFFICIAL PETITION AND WILL NOT RESULT IN A BALLOT REFERENDUM.**

If you disagree with the Secretary of State's actions, please sign the attached petition! Go Rogue New Mexico will keep you informed as the official petition makes its way through the courts and is ultimately approved. Your contact information **will not be** provided to the Governor or the Secretary of State—only your name.

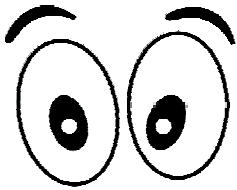

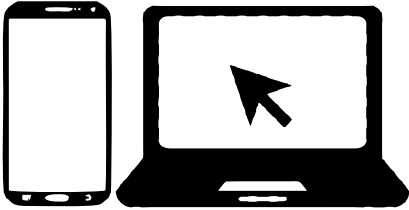

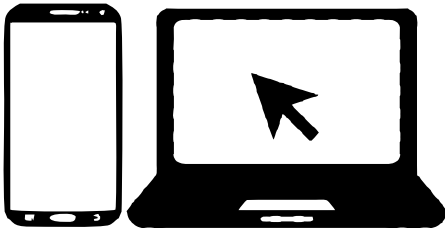
